

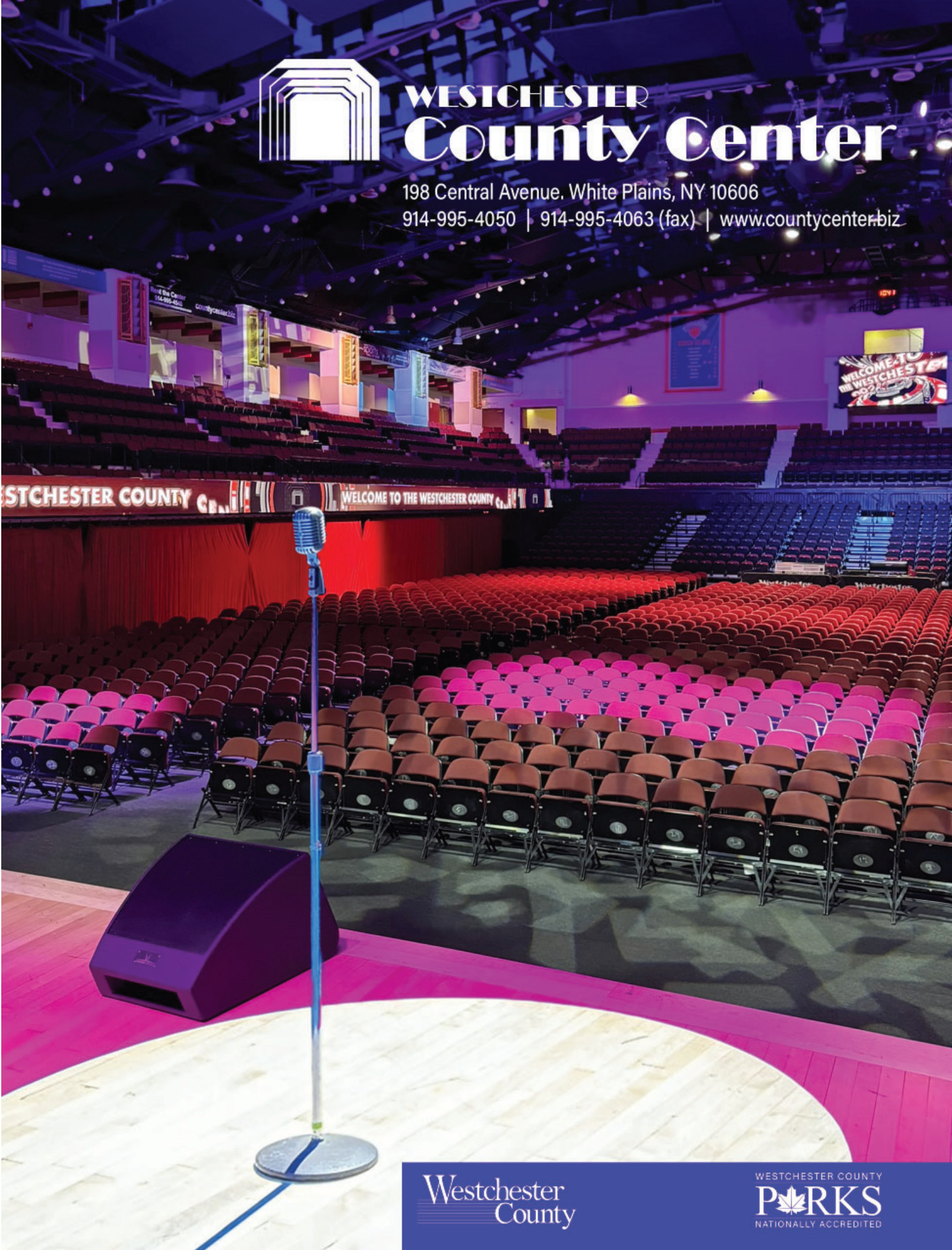

# building facts

The Westchester County Center in White Plains, New York, is an exceptional venue for vendors to host their events. It offers a multitude of benefits that make it an attractive choice for various types of gatherings, from trade shows and expos to conferences and entertainment events. Its strategic location, versatile facilities and excellent reputation have made it the region's premier venue since 1930.

The County Center's prime location and accessibility are among its key advantages. White Plains is the county seat and Westchester's commercial and shopping hub. Its proximity to New York City and the Tri-State area offers vendors access to a large and diverse audience. Westchester and its adjacent counties are home to about 2.5 million people.

The County Center is easily reached by I-287, I-684 the Hutchinson River Parkway, Saw Mill River Parkway, Taconic Parkway, Sprain Brook Parkway and Bronx River Parkway. Moreover, it sits next to a Metro-North commuter train station; the extensive Bee-Line local bus network also stops there.

The Westchester County Center boasts a range of versatile spaces that cater to events of all sizes and types. The main exhibition hall's 26,720 square feet of open floor space, maximum general admission

capacity of 5,000 and column-free layout allow vendors the flexibility to design their booths and displays without spatial constraints.

The Exhibition Hall is 12,800 square feet and

seats 1,200. The Little Theater is 2,800 square feet and seats 400. For smaller events, such as workshops, networking events or product demonstrations, seven meeting rooms seat approximately 100 people each. This adaptability ensures that the venue can meet the unique demands of a wide range of events, from small-scale gatherings to large conventions.

The Westchester County Center is equipped with high-speed internet, state-of-the-art audio-visual equipment and a multitude of electrical outlets. The Center's staff are experienced in event management and offer professional support, from setup to breakdown, which allows vendors to focus on their core business activities. The venue provides plenty of on-site parking; this reduces the stress on merchants and visitors to find parking in a busy area like White Plains.

Westchester County Center has built a strong reputation as a focal point for community activities, entertainment and business events. Its long history and consistent use for various high-profile events make it a well-known and trusted venue in the region.

# building amenities

Westchester County Center offers an on-site production office; air-conditioning throughout; seven carpeted meeting

rooms that hold from 70 to 370 people and each with its own sound system; a variety of seating configurations; sound and public address systems; elevators for the public and stage; direct parking for up to 2,000 vehicles; infrared listening devices for the hearing impaired; and restrooms on each floor on both sides of the arena.

is 43' high, though some areas are lower due to audio and/or lighting equipment. The ground-level freight elevator's access to the main level floor and stage is 8' -6" x 31' -9" and can hold 10,000 pounds. The Main Hall floor load is 100 pounds per square foot. It stands on the ground, main and second levels.

The County Center's total facility exhibit space on three levels holds 289 booths; each measures 8' x 10'. The Main Hall's ceiling

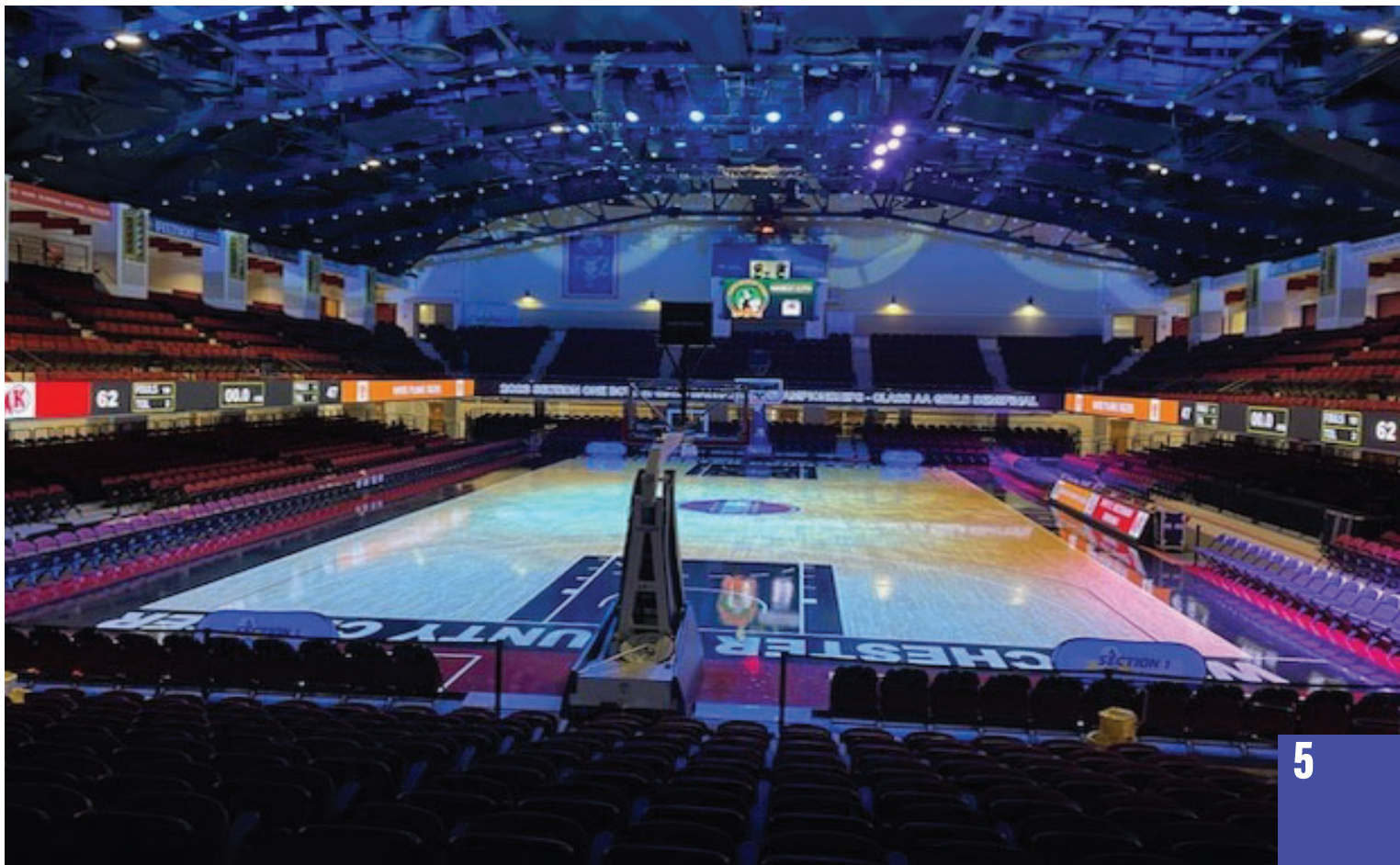

- 6 Dressing rooms
- Dressing Room A (Stage right, West): Stage level, accessible, 2 showers, 2 sinks, 2 toilets
- Dressing Room B (Stage right, West): 2nd level (no elevator), inaccessible, 4 showers, 1 sink, 1 toilet
- Dressing Room C (Stage right, West): 3rd level (no elevator), inaccessible, group showers, 4 sinks, 5 toilets
- Dressing Room D (Stage left, East): Stage level, accessible, 1 shower (inaccessible), 3 sinks (two accessible), 3 toilets (two accessible)
- Dressing Room E (Stage left, East): 2nd level (no elevator), inaccessible, 4 showers, 3 sinks, 3 toilets
- Dressing Room F (Stage left, East): 3rd level (no elevator), inaccessible, group shower, 3 sinks, 2 toilets

Since 1930, the art deco Westchester County Center has been the county's premier showcase for entertainment, sports and exhibitions. Westchester residents have enjoyed thousands of concerts, plays, sporting events, circus acts, seminars and community events.

The County Center recently updated the building by installing new luxury seating and risers to improve sightlines and customized acoustic panels, a fully digital sound system, plus 136 motorized lights to improve the concert experience in the Main Hall. The County Center also has Daktronics screens inside and outside of the venue.

In the Main Hall there are video boards flank-





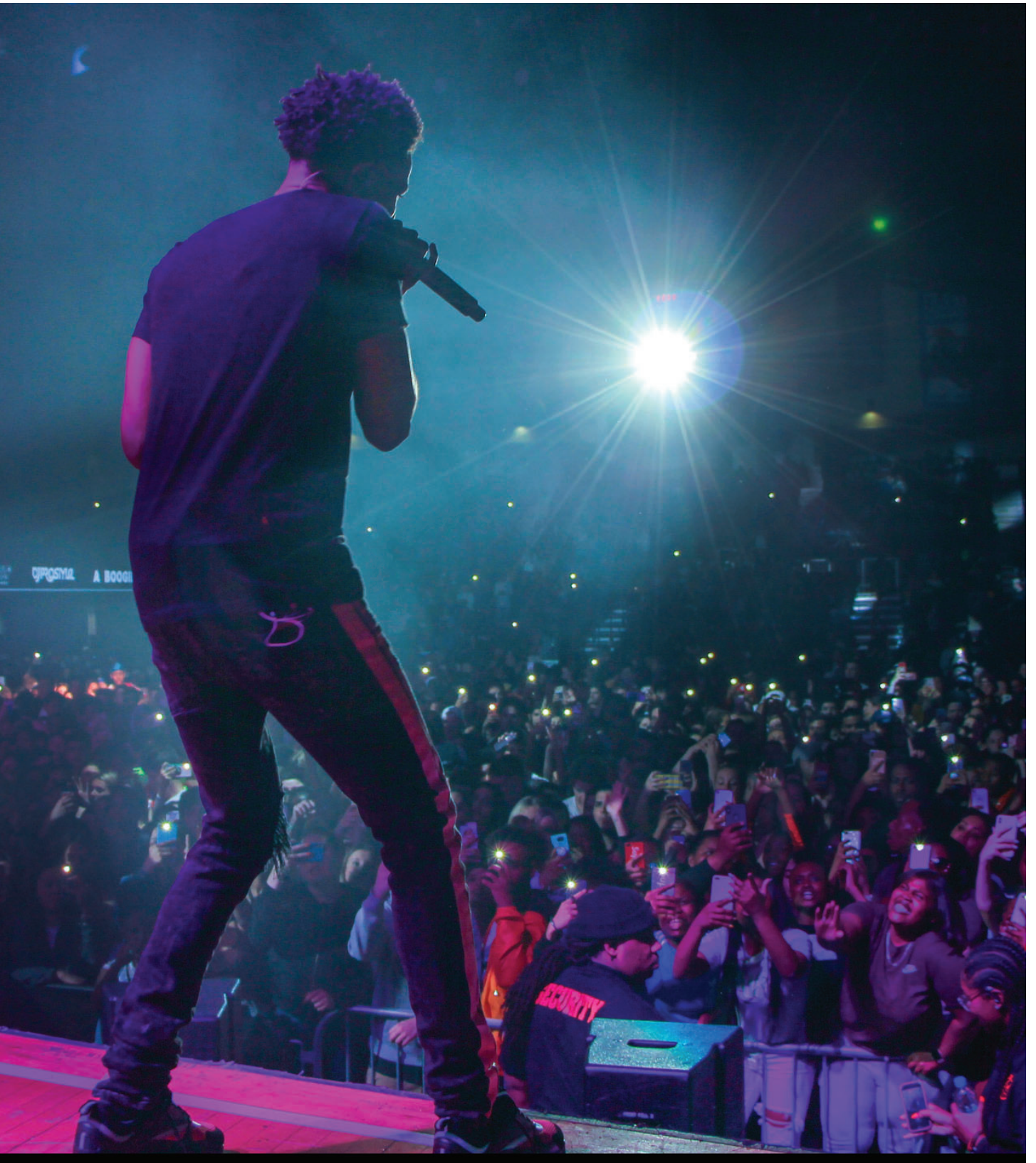


ing both sides of the stage, a screen in the center balcony and a display that runs along the entire façade of the balcony. The exterior boards consist of 5 video boards located just above the stairs of the main entrance, and a dual-sided marquee display.

The Westchester Knicks played at the County Center for the 2018 and 2019 Seasons. The County Center also has a rich history in boxing and wrestling. Muhammad Ali defeated Alonzo Johnson here in 1972. Since 1933, The Westchester County Center has been home to the Section 1 Basketball championships, and has recently also added the Section 1 Wrestling and Volleyball championships. The Westchester Sports Hall of Fame, with its over 270 inductees, is housed and displayed at the County Center.



## EVENTS

The Westchester County Center hosts many corporate and community events. Numerous high schools, colleges and universities hold their commencements at the Center. Groups such as the Archdiocese of New York, The Salvation Army, Heineken, WWE, The Harlem Globetrotters and The Royal Hanneford Circus; as well corporations such as Con Edison, Sterling National Bank and Greenwich Capital have staged events here. They appreciate the professionalism of the County Center's staff and exclusive caterer, Home-style Catering.



# production requirements

The visiting company shall provide identification and/or complete lists of all persons allowed to be in the backstage area. The list must be provided at load-in time. The Westchester County Center reserves the right to restrict backstage access. The house opens 1 hour prior to scheduled show time. All setup and sound checks must be completed by this time.

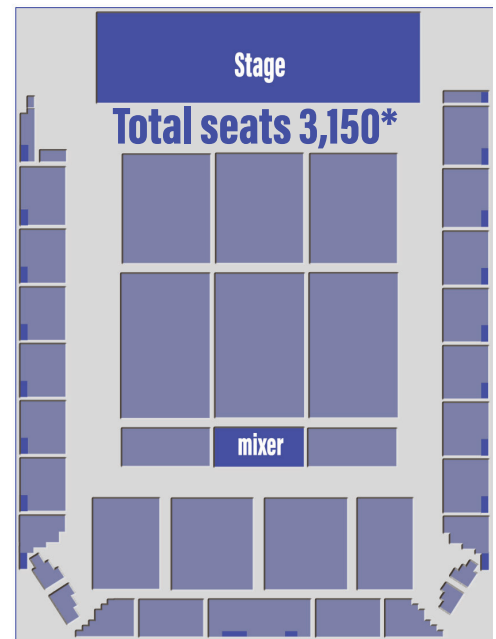
The production staff will assist the visiting company in opening the doors on time. Under no circumstances will the performance begin or intermission end without direct verbal approval from Westchester County Center staff.

The Westchester County Center will provide an area in front of the house for mixing and lighting controls approximately 100 feet from the stage. This area cannot be moved for any reason. Management reserves the right to control final sound level for any show at the Westchester County Center.

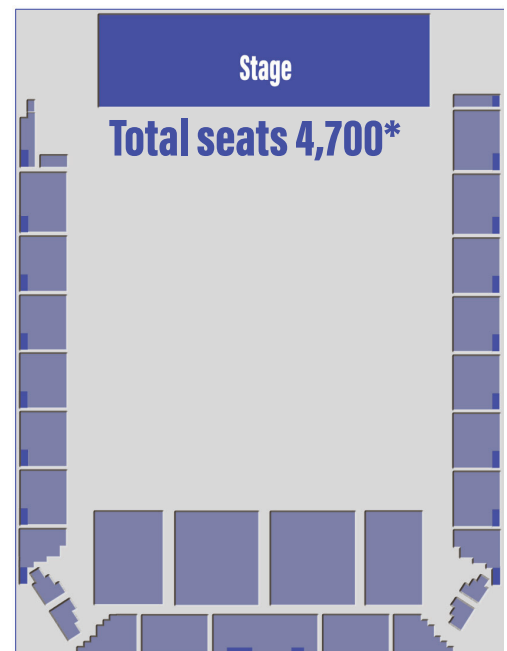
A Fire Marshal is required for all shows using haze and pyrotechnics. This must be discussed with the Westchester County Center in advance. Gaffers tape is the only tape allowed on floor surfaces in the facility.

The Westchester County Center has 24-hour security.

# getting to the County Center

**BY CAR** The Westchester County Center is at 198 Central Ave., White Plains, at the intersection of Central Ave., Tarrytown Rd., and the Bronx River Parkway.

**FROM THE NORTH:** Saw Mill River Parkway south to the Taconic Parkway to the Bronx River Parkway. Exit at Central Ave. in White Plains. Or take I-684 to I-287. Head north on 287, exit at Rt. 100/Tarrytown Rd. Take Tarrytown Rd. about 1 mile to Central Ave.

**FROM THE SOUTH:** From the South: The Bronx River Parkway to the Central Ave. exit in White Plains. Or take I-87, Saw Mill River Parkway, or Sprain Brook Parkway to I-287. Head south on I-287, exit at Rt. 100/Tarrytown Rd. Take Tarrytown Rd. about 1 mile to Central Ave.

**FROM THE EAST:** From the East: Take I-95 or the Hutchinson River Parkway to I-287. Head north on 287 to the Rt. 100/Tarrytown Rd. exit. Take Tarrytown Rd. about 1 mile to Central Ave.

**FROM THE WEST:** Take I-287 south to the Rt. 100/Tarrytown Rd. exit in White Plains. Take Tarrytown Rd. about 1 mile to Central Ave.

**BY TRAIN:** Take the Metro-North Harlem Line to the White Plains train station. Exit the train at the White Plains station. Walk in the direction of the front car. Take the stairwell at the north end of the platform. At the bottom of the stairs, turn left and walk through the pedestrian tunnel. Turn right after exiting the tunnel and continue to the County Center East Parking Lot. Follow

the path along the left edge of the parking lot. You will see the County Center ahead of you. Use the crosswalk at the traffic light to cross the Bronx River Parkway to the main entrance.

**FROM NEW YORK CITY:** The following NYC subways connect to Grand Central Terminal, which connects to White Plains via the Metro-North Harlem Line: 4,5,6 Lexington Ave., 7 Flushing local, and the Times Square Shuttle. The following New York City subways connect to Bee-Line buses: 11/9 Broadway/7th Ave., 2 White Plains Road, 4 Lexington Ave./Jerome Avenue, 5 Lexington Avenue/Dyre Ave., 5 Lexington Ave./White Plains Road, 6 Lexington Ave./Pelham Bay Parkway, B Fulton Street/8th Ave./Grand Concourse, D 6th Ave./Grand Concourse.

**BY BUS:** All Westchester County Bee-Line buses serve White Plains. Once your bus drops you at the White Plains Trans Center, walk across Ferris Ave. to the White Plains Metro-North Railroad Station. At the north end of the station, use the pedestrian tunnel that crosses under Metro-North's tracks, turn right as you exit the tunnel, and continue to the County Center East Parking Lot. Follow the path along the left edge of the parking lot. You will see the County Center ahead of you. Use the crosswalk at the traffic light to cross the busy Bronx River Parkway. The main entrance to the County Center will be on your right.
